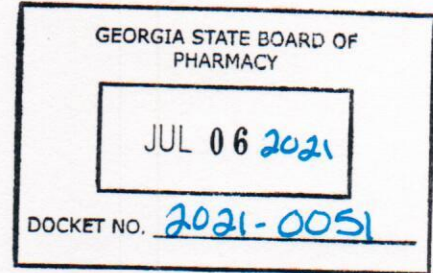

VOLUNTARY CEASE AND DESIST ORDER

Respondent, Dentsply North America, LLC, operating at
221 W. Philadelphia Street, Suite 60W, York, PA 17401,

is not licensed to engage in the distribution of drugs or devices in the State of Georgia, pursuant to the Official Code of Georgia Annotated (O.C.G.A.) T. 26, Ch. 4 or T. 16, Ch. 13, as amended. Potential violations of O.C.G.A. T. 26, Ch. 4 and T. 16, Ch. 13 having been called to Respondent's attention, Respondent, through the signing agent, hereby agrees to voluntarily cease and desist from any practice that would require licensure under O.C.G.A. T. 26, Ch. 4, or T. 16, Ch. 13, as amended, until such time as Respondent may become properly licensed or registered by the Georgia State Board of Pharmacy ("Board"). Respondent, through the signing agent, agrees that this includes distribution or delivery of drugs or devices to or receipt of drugs or devices from any person or firm in this state other than intracompany transfers to or from a licensed firm in this state under common ownership.

The Agent of Respondent understands that he/she has a right to a hearing in this matter, and hereby freely, knowingly, and voluntarily waives such right. The Agent of Respondent also understands that should he/she apply for licensure with the Board, the Board shall have access to this Order and to the entire investigative file on this matter.

This Order shall become effective immediately upon acceptance thereof and docketing by the Georgia State Board of Pharmacy and shall remain in effect until such time as the

Respondent becomes licensed with the Board, or until further order. The Agent of Respondent understands that this document will be considered to be a public record entered as the final disposition of any injunction or cease and desist proceedings presently pending or which could be brought against Respondent by the Board, and that this action shall be considered to be and may be recorded as a final order of the Board. **This Order is not intended and shall not be construed as prohibiting the prosecution of Respondent by any other state or federal agency for Respondent's conduct nor shall it be construed as limiting the Board's authority to subsequently impose a fine or conditions upon licensure with the Board.**

Any violation of this Order shall subject the Respondent to a fine not to exceed \$500.00 for each transaction constituting a violation thereof, pursuant to O.C.G.A. § 43-1-20.1.

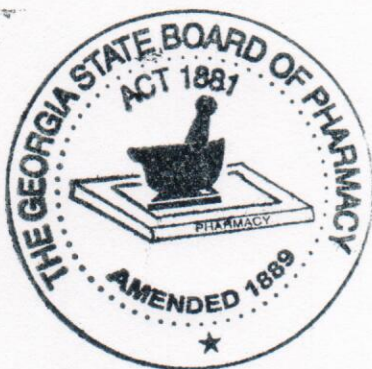
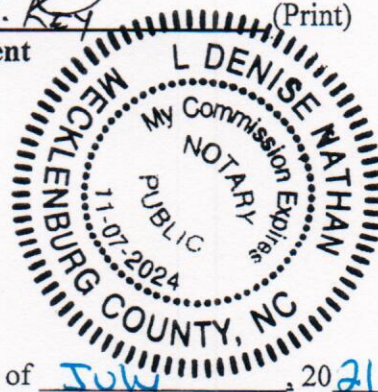
