President Jones welcomed the visitors.

Appearance

Appearance from Heather Lindell, PharmD, University of Georgia, Veterinary Teaching Hospital: Dr. Lindell presented information to the Board regarding Veterinary Feed Directive Drugs (VFD). Following Dr. Lindell's presentation, Ms. Wray asked if the drug is listed as a dangerous drug under Georgia law? Dr. Lindell responded yes. Ms. Wray asked if Georgia puts it under the dangerous drug act, how is it permissible to mix it themselves? Dr. Lindell responded that it is ordered directly from the sponsor or from VFD from the vet. The feed mill can order and mix it up.

Ms. Wray stated that some of the drugs listed in the presentation are not listed in dangerous drug act and some are. So we would have an issue for purposes of Georgia would have to follow dangerous drug act if you are a licensee. This needs to be addressed. If not used in humans, they are probably not on the list. President Jones thanked Dr. Lindell for the presentation.

Correspondence from Sherry Eddy, Archway

The Board considered this correspondence regarding wholesaler licensure for out of state 3PL's. Bill Prather made a motion to direct staff to respond by stating the Board suggests Ms. Eddy refer to O.C.G.A. § 26-4-115(a) for more information regarding this matter. Mike Faulk seconded and the Board voted unanimously in favor of the motion.

Correspondence from Gregory K. Stinnett, Hamilton Medical Center

The Board considered this correspondence asking can a pharmacist practice as a pharmacist in the hospital and not report to the pharmacist in charge. Bill Prather made a motion to direct staff to respond by stating the pharmacist should report to the pharmacist in charge. Additionally, request the policies and procedures from the hospital pharmacy on this activity. Jim Bracewell seconded and the Board voted unanimously in favor of the motion.

Correspondence from Paul Carpenter, Candler Hospital Pharmacy

The Board considered this correspondence regarding Candler Hospital and a private oncology infusion practice. Laird Miller made a motion to direct staff to respond by stating the Board recommends private doctors have their own space, area, and the two (2) are separate entities; or the hospital do retail pharmacy route and dispense to patients in physician's practices. Under that scenario the pharmacists would be operating as retail pharmacy, receiving patient-specific prescriptions, compounding and dispensing to patients and letting the physician's office licensed personnel administer to them. Jim Bracewell seconded and the Board voted unanimously in favor of the motion.

Correspondence from Shelley S. Albert

The Board considered this correspondence regarding wastage and proper disposal of such. Bob Warnock made a motion to direct staff to respond by stating the Board suggests she check with her own facility to see what policies and procedures are in place for wastage. Additionally, she may wish to confer with legal counsel regarding the code sections and rule chapter Ms. Foreman previously provided. Lisa Harris seconded and the Board voted unanimously in favor of the motion.

Correspondence from Scott Lange, AWARE Wildlife Center

The Board considered this correspondence requesting clarification as to whether or not vet techs and vet assistants are allowed to administer controlled substances for purposes like anesthesia and euthanasia. Laird Miller made a motion to direct staff to respond by stating, based on the information provided, the Board is concerned about the unlawful possession of controlled substances by a person who is not authorized to prescribe such. If Mr. Lange would like to submit additional information regarding this matter, he may submit it to the board office; however, the Board suggests he refer to the law and rules

pertaining to Veterinarians and Veterinary Technicians to determine if this is appropriate. Bill Prather seconded and the Board voted unanimously in favor of the motion.

The Board considered this correspondence regarding telepharmacy. Laird Miller made a motion to direct staff to respond by stating that the Board's law and rules do not permit telepharmacy at this time. Mike Faulk seconded and the Board voted unanimously in favor of the motion.

Bob Warnock made a motion to post Rule 480-24-.01 Definitions. Jim Bracewell seconded and the Board voted unanimously in favor of the motion.

Rule 480-24-.01 Definitions.

For purposes of these Rules and Regulations, the following definitions apply:

- (a) Board. Board shall mean the Georgia State Board of Pharmacy.
- (b) Crisis Stabilization Unit (CSU). Crisis Stabilization Unit (CSU) shall mean a medically-monitored, short-term, residential program which is an emergency receiving/evaluation facility that provides 24/7 psychiatric stabilization and detoxification services licensed by the Georgia Department of Behavioral Health and Developmental Disabilities (DBHDD).
- (b) (c) GDNA. GDNA shall mean the Georgia Drugs and Narcotics Agency.
- (c) (d) Hospice emergency drug kits. A hospice emergency drug kit shall mean an emergency drug kit placed by a provider pharmacy in a hospice licensed by the Department of Human Resources. Community Health.

(d) (e) Unit dose. A unit dose is a single dose of a medication(s), which is individually packaged, sealed, and properly labeled to maintain the integrity and the identity of the drug, and patient?_ready at the time of dispensing by the pharmacist.

The Board discussed Rule 480-24-.08 Crisis Stabilization Unit Emergency Drug Kits and recommended tabling this rule to allow additional time to review.

A motion was made by Jim Bracewell, seconded by Bob Warnock, and the Board voted that the formulation and adoption of this rule amendment does not impose excessive regulatory cost on any licensee and any cost to comply with the proposed amendment cannot be reduced by a less expensive alternative that fully accomplishes the objectives of the relevant code sections.

In the same motion, the Board also voted that it is not legal or feasible to meet the objectives of the relevant code sections to adopt or implement differing actions for businesses as listed at O.C.G.A§ 50-13-4(a)(3)(A), (B), (C) and (D). The formulation and adoption of this rule amendment will impact every licensee in the same manner, and each licensee is independently licensed, owned and operated and dominant in the field of pharmacy.
